

This month's helpful tip will be information. Recently in the City of Shoreacres an individual was stopped pulling a large trailer with a tank on it. On the tank was the word sealant. There were several other words like satisfaction guaranteed and several toll free phone numbers listed. This unscrupulous individual had a criminal history in six different states. He had spoken to an elderly lady in Shoreacres and was going to do a driveway seal for her later that day. This person did not obtain a permit to do work in the city. Officers knew he was pulling a scam. He had not yet started work for this citizen. After checking him out completely he was advised to leave the city and not return. The elderly lady was advised to contact police if anyone solicits her house again. The 1-800 numbers on the side of the tank were all to businesses other than his. Also earlier this month several young men and teens were going door to door selling magazines. None of these people obtained a permit to solicit in the city. When we called the phone numbers listed by their company they were disconnected. They were given tickets in municipal court and made to leave the area. Any citizen who is approached by a solicitor in the city should call City Hall to see if they have obtained a permit to do so.

On April 14, 2008, Shoreacres Police Officer M. Newman will begin her classes to become certified as a Commercial Vehicle Inspector. For the first time the State of Texas is giving a certified school at the Seabrook fire station. Upon completion of this school Officer C. Newman will be one of only a few female Police Officers certified to do Commercial Vehicle Inspections. She will receive her on the job required training here by Corporal D. Manolescu who is in charge of the Commercial Vehicle Inspection Division.

Attached are the month to month stats along with the DOT stats. The clearance rate this month is 96%, twenty four out of twenty five cases closed.
