

I have started the background investigation on the new replacement officer and hope to finish it soon so he can start the second process. We would like to have him on board before the end of June. When he comes to work Officer C. Newman will move to full time Commercial Vehicle Inspections.

School will soon be out for the summer. The city curfew will still be in effect but not the part about being out during school hours. Anyone wanting to know the curfew regulations just call me at City Hall. They can also be found in the city code on the city's web sight along with all the other city ordinances. Please be aware that the school zones in La Porte will still be in effect for summer school. Drive accordingly.
