Work on City Hall is still in progress. The work downstairs will start this week. When complete council meetings, municipal court and jury trials will have a new room to meet in. The restrooms will also be remodeled. The trailer located on the eastside of City Hall will soon be moved. The new police vehicle has been equipped and placed on the dayshift patrol.

The construction on State Highway 146 at Shoreacres and Choate Road will be with us for some time to come. I have spoke to TXDOT about the mud mostly on Choate Road. They have agreed to keep it clean. They also stated they will no longer block traffic going east and west across Highway 146 at the peak traffic times to unload dump trucks.

Starting next week the code enforcement officer will survey the city and mail out municipal citations for code violations. No information letter will be sent this time giving citizens ten days to correct the violation. If you put up orange webbing around your pool for a temporary fix and it is falling down it should have been repaired. Building debris and junk (not licensed) vehicles should also be taken care of. At this time tall grass is not a real problem but tall weeds should be cut down. Any citizen who has a question about possible code violations can contact me at City Hall.
