### INTERGOVERNMENTAL AGREEMENT FOR SECURITY SERVICES

#### Recitals

THIS AGREEMENT is made and entered into July 1, 2004, between the **PORT OF HOUSTON AUTHORITY OF HARRIS COUNTY, TEXAS**, a political subdivision of the State of Texas ("the Port Authority"), and the **CITY OF SHOREACRES**, a municipality and political subdivision of Texas, to be addressed at 601 Shoreacres Boulevard, Shoreacres, Texas 77571 ("the City").

By Minute 2004-0524-47 of its meeting of May 24, 2004, the Port Commission, the governing body of the Port Authority, authorized the expenditure of TWENTY THOUSAND ONE HUNDRED EIGHTY EIGHT AND 00/100 DOLLARS (\$20,188.00) for the services and expenses of the City described in this Agreement.

The Port Authority and the City agree to the terms and conditions of this contract.

#### Agreement

- 1. **Services.** The Shoreacres Police Department will do the following at the Port Authority's Bayport property:
  - a) Perform normal patrol each day at irregular intervals several times daily and at night, of both the North and South side of property at Bayport Channel.
  - b) Respond to all citizen complaint calls concerning various activities on the Port Authority's Bayport property.
  - c) Apprehend and arrest firearm violators and other violators of the Texas Criminal Codes and Statutes on the Bayport property.
  - d) Communicate with Port Authority representatives concerning all police/ security matters pertaining to the Bayport property.
  - e) Furnish copies of official records and reports of incidents occurring on the Bayport property.
- 2. **Term.** This Agreement will be in effect for the twelve-month period beginning July 1, 2004 and ending June 30, 2005.

3. **Payment**. It is agreed between the parties that the cost of security services and expenses required by this Contract must not exceed **TWENTY THOUSAND ONE HUNDRED EIGHTY EIGHT AND 00/100 DOLLARS (\$20,188.00)** during the full term of this contract, to be paid in four successive quarterly installments, in the amount of **FIVE THOUSAND FORTY SEVEN AND 00/100 DOLLARS** (\$5,047.00).

The parties to this Agreement execute this Agreement and seal it in multiple copies, each will be considered an original but all will evidence only one agreement, on the date first written above.
