ORDINANCE NO. 2006 - 04

APPOINTMENT OF ELECTION OFFICIALS FOR THE MAY 13, 2006 GENERAL ELECTION

AN ORDINANCE APPOINTING THE ELECTION JUDGE, ALTERNATE JUDGE, ELECTION CLERKS, AND APPOINTMENT OF A BILINGUAL VOTING CLERK AND MARSHAL FOR THE MAY 13, 2006, GENERAL ELECTION.

WHEREAS, the laws of the State of Texas provide that on May 13, 2006, there shall be elected two (2) Alderman-at-large and, one Mayor (1) each for a two year term for the City of Shoreacres.

WHEREAS, state law requires that the City Council appoint certain election officials,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SHOREACRES, STATE OF TEXAS:

Section 1. That the following persons be appointed as Election Officials for the May 13, 2006, General Election and that they be compensated at a rate of ten dollars (\$10.00) per hour for all hours worked including DRE (Direct Recording Electronic) voting machine Training and the Election School.

Meredith Wilson Election Judge and Judge of Early Voting Balloting Board.

Lee Barnett Alternate Election Judge and Clerk of Early Voting Balloting Board.

Polly Stanton Election Clerk and Clerk of Early Voting Balloting Board.

SECTION 2. That the Election Judge or Alternate Judge may appoint replacement clerks in the event that any of the above persons are unable to serve on Election Day. These replacements shall also serve at the rate of ten dollars (\$10.00) per hour for all hours worked.

SECTION 3. That Robin Eldridge be appointed the Early Voting Election Clerk and that David Stall be appointed the Alternate Early Voting Clerk.

SECTION 4. That Sergeant Sam Bianchino be appointed as City Marshal for the May 13, 2006 General Election and as such shall be the one who delivers the returns of the election to the La Porte City Hall, located at Fairmont Parkway as it is the designated place for Central Counting.

SECTION 5. Direct recording electronic voting machines (DRE'S) shall be used for voting at the election precinct and electronic counting devices and equipment shall be used for counting the ballots for early voting and elections day.

SECTION 6. Appointment of bilingual Election Clerk for Election day, May 13, 2006. Barbara Eldridge is hereby appointed as our Bilingual Election Clerk
