

**ORDINANCE No. 2012-125  
CITY OF SHOREACRES, TEXAS**

AN ORDINANCE AMENDING THE CODE OF THE CITY OF SHOREACRES TO REGULATING NO PARKING ZONES WITHIN THE CITY LIMITS; CONTAINING A SEVERABILITY CLAUSE; PROVIDING FOR THE PUBLICATION OF THE CAPTION HEREOF; MAKING VARIOUS FINDINGS AND PROVISIONS RELATING TO THE SUBJECT; FINDING COMPLIANCE WITH THE OPEN MEETINGS LAW; AND PROVIDING AN EFFECTIVE DATE HEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SHOREACRES:

That, the facts and matters set forth in the preamble of this Ordinance are hereby found to be true and correct; and,

That if any section, clause, sentence, or phrase of this Ordinance is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Ordinance; and,

That the City Council officially finds, determines, recites, and declares that a sufficient written notice of the date, hour, place and subject of this meeting of the City Council was posted at a place convenient to the public at the City Hall of the City for the time required by law preceding this meeting, as required by the Open Meetings Law, Chapter 551, Texas Government Code; and that this meeting has been open to the public as required by law at all times during which this ordinance and the subject matter thereof has been discussed, considered and formally acted upon. The City Council further ratifies, approves and confirms such written notice and the contents and posting thereof.

That section 62-152 of the Shoreacres City Code is hereby amended to read as follows:

**Sec. 62-152. Stopping, standing, or parking prohibited in specified places.**

- (a) *Parking not to obstruct traffic.* No person shall park any vehicle upon a street, in such a manner or under such conditions as to leave available less than 12 feet of the width of the roadway for free movement of vehicular traffic.
- (b) *Parking for certain purposes prohibited.* No person shall park a vehicle upon any roadway for the principal purpose of:
  - (1) Displaying such vehicle for sale.
  - (2) Washing, greasing or repairing such vehicle except repairs necessitated by an emergency.
- (c) *No parking zones.* Except when necessary to avoid conflict with other traffic, or in compliance with law or the direction of a police officer, or for

the purpose of loading or unloading passengers, no person shall park, stand, or stop a motor vehicle at any time in the following zones:

- (1) On the east side of Miramar.
- [(2) On Shoreacres Boulevard opposite the Shoreacres Fire Station.
- (3) On Byway from Fairfield to Meadowlawn.
- (4)](2) On the outer area of Park Circle.
- (3) On State Highway 146 (main lanes or ramps).
- [(5) On the east side of Westview from Fairfield to Meadowlawn.]
- (d) *No parking in the parks.* No person shall park, stand, or stop upon the park area on Miramar or in Circle Park, Heron Park, Bayou Forest Park or Taylor Bayou Park.

This Ordinance shall be effective upon its passage and approval. The City Secretary shall give notice of the passage of this ordinance by causing the caption hereof to be published in the official newspaper of the City of Shoreacres at least once after the passage of this ordinance.
