ORDINANCE No. 2016-214 CITY OF SHOREACRES, TEXAS

AN ORDINANCE AMENDING THE CODE OF THE CITY OF SHOREACRES REGARDING SPECIAL MEETINGS; CONTAINING A SEVERABILITY CLAUSE; MAKING VARIOUS FINDINGS AND PROVISIONS RELATING TO THE SUBJECT; FINDING COMPLIANCE WITH THE OPEN MEETINGS LAW; AND PROVIDING AN EFFECTIVE DATE HEREOF.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SHOREACRES, TEXAS:

That section 2-62 of the Shoreacres City Code is hereby amended to read as follows:

Sec. 2-62. - Special meetings.

Special meetings may be called on the motion of the mayor or at the request of any three members of the city council. If the request is made by members of the council, it shall be made to the mayor, who shall [will] call the special meeting for the time and date requested and cause the agenda to be posted within 24 hours of the request. If the mayor fails, is unable, or refuses to call the special meeting, the mayor pro tempore shall call the special meeting for the time and date requested. In the event of a special meeting, notice of the meeting shall be posted at the city hall at least 72 hours before such meeting is to be held. The notice shall contain the date, hour, place and subject matter of the meeting and shall be signed by the city secretary. The agenda shall indicate who called the meeting. Each member of city council and the city attorney must be notified of the special meeting. Emergency meetings shall be called in accordance with V.T.C.A., Government Code § 551.045 and V.T.C.A., Local Government Code § 22.038.

* * * *

That if any section, clause, sentence, or phrase of this Ordinance is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Ordinance; and,

That the City Council officially finds, determines, recites, and declares that a sufficient written notice of the date, hour, place and subject of this meeting of the City Council was posted at a place convenient to the public at the City Hall of the City for the time required by law preceding this meeting, as required by the Open Meetings Law, Chapter 551, Texas Government Code; and that this meeting has been open to the public as required by law at all times during which this ordinance and the subject matter thereof has been discussed, considered and formally acted upon. The City Council further ratifies, approves and confirms such written notice and the contents and posting thereof.
