

ORDINANCE No. 2016-232

AN ORDINANCE AND ORDER ADOPTING AN ORDER APPROVING THE CITY OF SHOREACRES, TEXAS, 2016 PROPERTY TAX ROLL.

WHEREAS, the Chief Appraiser of the Harris County Appraisal District, pursuant to Section 26.01, Texas Property Tax Code, as amended, have certified to the Assessor/Collector of the City of Shoreacres that the part of the appraisal roll for such Appraisal District that lists the property taxable by the City of Shoreacres and its values; and,

WHEREAS, the Tax Assessor/Collector for the City of Shoreacres, has, pursuant to Section 26.04, Texas Property Tax Code, as amended, submitted the certified appraisal rolls for the City of Shoreacres to the Mayor and Council of the City of Shoreacres showing the total appraised, assessed, and taxable values of all property and the taxable value of new property;

NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SHOREACRES, STATE OF TEXAS, THAT:

Section 1. The appraisal roll as submitted by the Assessor/Collector for the City of Shoreacres for the year 2016 be, and is hereby, in all things approved as the Property Tax Roll for the City of Shoreacres.

Section 2. Such Order shall be effective from and after the date of its passage as made and provided by applicable laws of the State and of the City of Shoreacres.

Section 3. That the City Council officially finds, determines, recites, and declares that a sufficient written notice of the date, hour, place and subject of this meeting of the City Council was posted at a place convenient to the public at the City Hall of the City for the time required by law preceding this meeting, as required by the Open Meetings Law, Chapter 551, Texas Government Code; and that this meeting has been open to the public as required by law at all times during which this ordinance and the subject matter thereof has been discussed, considered and formally acted upon. The City Council further ratifies, approves and confirms such written notice and the contents and posting thereof.
