

**RESOLUTION No. 2016-179  
CITY OF SHOREACRES**

A RESOLUTION OPPOSING ANY LEGISLATION THAT INCREASES THE MAXIMUM TRANSPORT HAUL WEIGHTS OVER ROADWAYS IN THE CITY OF SHOREACRES; MAKING VARIOUS FINDINGS AND PROVISIONS RELATING TO THE SUBJECT; FINDING COMPLIANCE WITH THE OPEN MEETINGS LAW; AND PROVIDING AN EFFECTIVE DATE HEREOF.

WHEREAS, legislation may be proposed in the 2017 Texas Legislative Session to allow trucks to increase their maximum haul weight from 80,000 pounds to up to 97,000 pounds along certain roadways within the City of Shoreacres; and,

WHEREAS, the City of Shoreacres is concerned about the safety of our citizens as a result of increasing maximum transport haul weights; and,

WHEREAS, the City of Shoreacres is concerned about the effects to the transportation infrastructure from any additional maximum transport haul weights;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SHOREACRES, TEXAS:

THAT, the City of Shoreacres opposes any legislation that would increase the maximum transport haul weights for trucks within the City of Shoreacres.

THAT, the City Council officially finds, determines, recites, and declares that a sufficient written notice of the date, hour, place and subject of this meeting of the City Council was posted at a place convenient to the public at the City Hall of the City for the time required by law preceding this meeting, as required by the Open Meetings Law, Chapter 551, Texas Government Code; and that this meeting has been open to the public as required by law at all times during which this resolution and the subject matter thereof has been discussed, considered and formally acted upon. The City Council further ratifies, approves and confirms such written notice and the contents and posting thereof.

This Resolution shall take effect immediately upon passage.
