

**RESOLUTION No. 2016-186  
CITY OF SHOREACRES**

A RESOLUTION AUTHORIZING ALDERMEN TO CONSULT WITH THE CITY ATTORNEY WITH CERTAIN LIMITATIONS; DIRECTING THE CITY ATTORNEY TO ATTEND CITY COUNCIL MEETINGS UPON REQUEST; MAKING VARIOUS FINDINGS AND PROVISIONS RELATING TO THE SUBJECT; FINDING COMPLIANCE WITH THE OPEN MEETINGS LAW; AND PROVIDING AN EFFECTIVE DATE HEREOF.

WHEREAS, the city attorney serves as the legal advisor of, and the attorney for, all of the officers, offices, and departments of the city; and,

WHEREAS, the city attorney may be called upon to draft, review, approve, or file written legal objections to, any ordinance before it is acted upon by the council; and,

WHEREAS, the city attorney reviews documents, contracts, and other legal instruments in which the city may have an interest and which council may act to approve; and,

WHEREAS, timely access to the city attorney's legal advice and opinions is fundamental to the efficient legislative operation of city council;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SHOREACRES, TEXAS:

THAT, City of Shoreacres aldermen may consult the city attorney outside of a city council meeting on legal matters directly related to their office, ordinances or documents that may come before council, or the performance of their duties as an alderman, provided that such consultation does not exceed one hour per calendar month; and,

THAT, with the concurrence of the mayor or approval of council, City of Shoreacres aldermen may consult the city attorney outside of a city council meeting on legal matters related to their office in excess of one hour per calendar month to the limit authorized by the mayor or council, if any; and,

THAT, with reasonable notice the city attorney or his representative shall attend any meeting of the city Council upon the request of the mayor or upon the request of two or more aldermen; and,

The City Council officially finds, determines, recites, and declares that a sufficient written notice of the date, hour, place and subject of this meeting of the City Council was posted at a place convenient to the public at the City Hall of the City for the time required by law preceding this meeting, as required by the Open Meetings Law, Chapter 551, Texas Government Code; and that this meeting has been open to the public as required by law at all times during which this resolution and the subject matter thereof has been discussed, considered and formally acted upon. The City Council further ratifies, approves and confirms such written notice and the contents and posting thereof.

This Resolution shall take effect immediately upon passage.
