

**RESOLUTION No. 2017-279
CITY OF SHOREACRES**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SHOREACRES, TEXAS SCHEDULING A PUBLIC HEARING ON THE PROPOSED BUDGET OF THE CITY FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2017 AND ENDING SEPTEMBER 30, 2018; PROVIDING THAT A PUBLIC HEARING ON THE PROPOSED BUDGET WILL BE CONDUCTED AT A MEETING OF THE CITY COUNCIL TO BE HELD ON SEPTEMBER 25, 2017, COMMENCING AT 7:00 P.M., AT THE SHOREACRES CITY HALL; PROVIDING AN EFFECTIVE DATE

WHEREAS, the City Council of the City of Shoreacres, Texas (the "City") is in the process of evaluating and establishing a budget for its fiscal year that begins October 1, 2017 and ends September 30, 2018; and

WHEREAS, on August 21, 2017, the City Manager as Budget Officer of the City of Shoreacres submitted a proposed budget for the City of Shoreacres Fiscal Year 2017-2018 to the City Council; and,

WHEREAS, on August 21, 2017, the proposed budget for the City of Shoreacres was filed with the City Secretary; and,

WHEREAS, Section 102.006 of the Texas Local Government Code provides that the City Council must set a public hearing on the proposed budget and provide for public notice of the date, time and location of the hearing; and,

WHEREAS, Section 22.038 of the Texas Local Government Code provides that the governing body of the city shall meet at the time and place determined by resolution adopted by the governing body;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SHOREACRES, TEXAS:

Section 1. The City Council will hold and conduct a public hearing on the proposed budget for the City for the 2017-2018 Fiscal Year on September 25, 2017 commencing at 7:00 p.m. at Shoreacres City Hall, Council Chambers, 601 Shore Acres Blvd., Texas 77571. Notice of the said meeting and public hearing will be published and posted in accordance with law.

Section 2. The above and foregoing recitals are true and correct and are incorporated into and made a part of this Resolution.

Section 3. The City Council officially finds, determines, recites, and declares that a sufficient written notice of the date, hour, place and subject of this meeting of the City Council was posted at a place convenient to the public at the City Hall of the City for the time required by law preceding this meeting, as required by the Open Meetings Law, Chapter 551, Texas Government Code; and that this meeting has been open to the public as required by law at all times during which this resolution and the subject matter thereof has been discussed, considered and formally acted upon. The City Council further ratifies, approves and confirms such written notice and the contents and posting thereof.

Section 4. This Resolution shall take effect upon its passage and approval.
