A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SHOREACRES, TEXAS, THANKING THE COMMUNITY OF BLUFFTON, SOUTH CAROLINA, FOR THE CONCERN AND SUPPORT SHOWN TO THE CITIZENS OF SHOREACRES IN THE WAKE OF HURRICANE HARVEY; MAKING VARIOUS FINDINGS AND PROVISIONS RELATING TO THE SUBJECT; FINDING COMPLIANCE WITH THE OPEN MEETINGS LAW; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the cities of Shoreacres, Texas, and Bluffton, South Carolina, share common risks and vulnerabilities for flooding and storm surge from tropical storms and hurricanes; and,

WHEREAS, these two cities are waterfront communities, Shoreacres on the western shore of Galveston Bay, and Bluffton on the bank of the May River; and,

WHEREAS, the City of Shoreacres suffered storm surge flooding from Hurricane Harvey, causing flood water to enter and damage more than fifty homes; and,

WHEREAS, a group of concerned Blufftonians built a groundswell of support for Shoreacres' flood victims; and,

WHEREAS, the greater Bluffton community exhibited a much appreciated willingness to reach out and lend support to our flood victims;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SHOREACRES, TEXAS:

THAT the City Council of the City of Shoreacres, on behalf of all of its citizens, hereby extends a sincere thank you and this statement of our appreciation for the concern and support shown to the citizens of Shoreacres in the wake of Hurricane Harvey.

THAT the facts and recitations set forth in the preamble of this resolution be, and they are hereby, adopted, ratified, and confirmed.

This Resolution shall take effect upon its passage and approval.
