2.1 Citizen's Comments

<u>Stan Krauhs, 1103 Shoreacres Blvd</u>: Reported that Houston is now recycling plastic numbers 1, 2, 3, 4, 5, and 7. He asked if the City of Shoreacres will pursue recycling more plastics. He also inquired about any problem recycling bottles with the top ring in place.

Anita Willis, 1009 Forest: Asked about the city's recycling program. Reported hearing a high-frequency noise Saturday from the west side of SH-146 from 10:00am (or noon) to 3:30pm. Asked why council selected East Bayou for repaving. Reported that she contacted the American Lung Association about air quality issues and learned that the Port Terminal has an emission offset. She has received Clean Ports USA information. Noted that diesel exhaust is classified as a carcinogenic this is produced by the plants, tugs, ships, etc. Asked if the community could get a monitor for particulate matter. And, reported that she had spoken with the EPA office in Sugar Land.

<u>Patrick Stanton, 128 Shadylawn</u>: Requested that when the City does it's needs assessment that it consider maintenance of drainage pipes under driveways and that they be kept clear all year. He noted that homeowners are not equipped to maintain the culverts and that expense should be considered in the budget.
