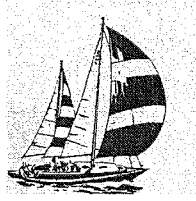


# City of Shoreacres

## 7.0 ADMINISTRATIVE REPORTS

7.1 City Administrator Report: Mr. Stall reported on the following: Today the City took swift action to notify/updates Shoreacres subscribers via Blackboard Connect, e-mail and SMS messages, about the chemical release siren and status of the ship collision at the Houston Ship Channel near Morgan's Point. TxDOT has received funding to re-surface Spur 501 (Old Hwy 146) from Wharton Weems to Shady Lane. We should anticipate that the project will start sometime this year.

7.2 Monthly Police Department Report – Chief Harrison thanked Mr. Stall for initiating an effective notification to Shoreacres citizens, as we experienced the ship collision today. He noted how important it is for correct information to be disseminated to the citizens to avoid misinformation. He also advised that his department will be actively pursuing the enforcement of City Code and Ordinances violations.

7.3 Monthly Public Works Department Report – Mr. Stall reported that ditch work maintenance will begin within the next thirty days. Our Public Works department is now fully staff we will introduce our new employee and police officer at the next council meeting.


