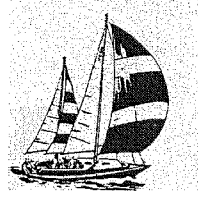

### **PUBLIC HEARING ON THE PROPOSED BUDGET FOR THE CITY OF SHOREACRES, TEXAS**

Notice is hereby given that the City Council of the City of Shoreacres will hold a Public Hearing on the 28th day of September 2015, in the Council Chambers of City Hall, 601 Shore Acres Blvd., Shoreacres, Texas, beginning at 7:00 P.M. The purpose of this hearing is to provide citizens the opportunity to comment on the overall budget.

This Budget will not raise more total property taxes than last year's budget. The amount of tax revenue to be raised from new property added to the tax roll this year is \$2,847.66.

All citizens are invited to attend and participate with both written and/or oral comments and/or questions concerning the entire 2015/2016 Budget, including all funds in the General Fund and Utility Fund.

Copies of the proposed budget may be inspected by the public at City Hall, 601 Shore Acres Blvd., between the hours of 8:00 a.m. and 5:00 p.m., Monday through Thursday; and, 8:00 a.m. and noon Friday. The proposed budget is also available on the city's website.
