The average taxable value of a residence homestead in the City of Shoreacres last year was \$160,431. Based on last year's tax rate of \$0.844381 per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$1,354.65.

The average taxable value of a residence homestead in City of Shoreacres this year is \$185,399. If the governing body adopts the effective tax rate for this year of \$0.765505 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$1,419.24.

If the governing body adopts the proposed tax rate of \$0.826745 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$1,532.78.
