### Please Observe City Sign Regulations

#### Garage Sale Signs.

Garage sale signs may be posted the day of a garage sale and must be removed within 24 hours after the garage sale.

A maximum of five signs, posters, or advertisements are allowed, and none are permitted to remain in a public place for a period longer than three days. Each sign must state the date(s) of the sale. Signs may be placed in the city rights-of-way but not on any traffic sign pole, street sign pole, or utility pole. Signs in violation of the City Code are subject to being removed and discarded without notice.

#### Temporary Signs.

Only one, "For Sale", "For Rent" or "For Lease" sign is allowed property for sale, rent, or lease. The sign cannot be larger than six square feet and cannot be placed within 20 feet of the edge of the street, or within ten feet of the adjoining property line.

Only one building contractor, architect, or subcontractor sign may be placed on a building site during construction. The sign cannot be larger than sixteen square feet and cannot be placed within 20 feet of the edge of the street, or within ten feet of the adjoining property line.

No permitted sign may be taller than five feet above ground level.

### Please Observe Our Parking Ordinance

The City has an ordinance regulating the parking of cars, trucks, trailers and other vehicles on city streets and residential lots.

**No vehicle of any kind may be parked on the street, shoulder or on public property for longer than forty-eight (48) hours.**

**No truck tractor, semi-trailer, farm tractor, or bus shall be parked on private property for longer than twenty-four (24) hours.**

**No truck tractor, semi-trailer, motor home, bus, or trailer of any kind shall be parked on the street or shoulder at anytime *unless* actively being used to provide a service to the adjacent property (moving vans, lawn service, etc.).**

Additionally, no vehicle shall be parked on any private property without the permission of the property owner.

A violation of this ordinance is punishable by a fine of up to \$500 for each day the violation exists.
